



## PRIVACY POLICY

Pollock Orora is committed to safeguarding your privacy online. This Privacy Policy describes the measures we take to help ensure the security of information collected through our website.

### How Personal Information is Collected and Used

Pollock Orora only collects personal information that you voluntarily submit through our website. This may include information such as your name, street and e-mail addresses, and telephone number. We do not automatically collect personal information without your knowledge.

### Uses of Personal Information

We collect personally identifiable information when you send us requests for information through our website. We may also collect information from our affiliates and business partners. We will only use your personal information for these general purposes:

- To respond to your questions or comments
- To better understand your purchasing habits and needs
- To help us understand how we can improve our products, services and website
- To inform you about special promotions
- To contact you to ask for your opinion or willingness to participate in certain events

### Information Sharing and Disclosure

We will send personally identifiable information about you to others when:

- We have your consent to share the information
- We need to share the information to provide a service you have requested
- We need to send the information to companies or people who work on behalf of Pollock Orora to provide a service to you
- We respond to subpoenas, court orders or other legal requirements
- We find that your actions on our site violate any applicable terms of use or usage guidelines
- We need to share the information to ensure the security and accuracy of the site
- An affiliate or third party wishes to have access to your information to provide you with goods or services which may be of interest to you

Please note that we may disclose personally identifiable information when required by law or in the good-faith belief that doing so would be necessary in order to comply with legal process served on us.

## Use of Cookies

To improve your visit to our site, we may use "cookies" to obtain non-personal information (cookies are text information files that your browser places on your computer when you visit a website). We may aggregate this data to analyze the viewing habits of our site visitors, but it will not be associated with any personally identifiable data.

## Access to Your Information

To modify your personal information, see the "Contact Us" section of this site and send us a request indicating such desire. We will make every effort to respond to your requests in a timely manner. If you have already submitted personal information to Pollock Orora, you may opt out of the company's future use of that information by sending an e-mail to us as indicated in the "Contact Us" section of our site. ## Security of Your Information

The security of your personal information is very important to us. We use appropriate technical and managerial procedures to protect your personal information and prevent its disclosure outside Pollock Orora.
